- 1.0 DB POWER LIMITED (DBPL) hereby invites bids in two parts (i.e. Part –I: Techno - commercial bid and Part – II: Price Bid) from reputed Railway approved organizations with proven track record for Construction of Railway Siding for Execution of P-way work from plant yard to Robertson Station for Construction of Railway Siding for 1200 (2 x 600) MW coal based thermal Power Plant of DB Power Limited at Village-Baradarha, Tehsil-Dabhra, District-Janjgir-Champa,Chhattisgarh, India, as per scope of work mentioned hereinafter.
- 2.0 **Scope of Work: The brief scope of Work is as under:**

The Bidder will be responsible for the entire scope of work for Execution of P- way work (excluding Earthwork & Civil Work) along with supply of P-way materials (excluding Rails, Sleepers, Points & Crossings which shall be issued free by DBPL) form Plant yard to Robertson Station for Construction of Railway Siding for 1200 (2 x 600) MW coal based thermal Power Plant of DB Power Limited in State of Chhattisgarh (INDIA). The Bidder shall execute all the works in accordance with the technical specifications and approved drawings and as per the detailed scope of work indicated in the bidding documents.

Bids not accompanied by the requisite Bid Security / Earnest Money in a separate sealed envelope or bids accompanied by the Bid Security / Earnest Money of inadequate value may not be entertained and in such cases, bids may be returned to the Bidders without being opened.

6.0 Qualifying requirement for Bidders

In addition to the requirements stipulated in Cl.-13.2.1-e, Part- B of Bidding document, the Bidder should also meet the Qualifying Criteria stipulated below.

Financial Capability and Stability:

- I. Does not anticipate a change in ownership during the proposed period of execution of work (if such a change is anticipated, the scope and effect thereof shall be defined).
- II. The minimum annual average turnover of the bidder should be at least Rs. 30 Crores (Rupees Thirty Crores only) during the preceding five consecutive financial years.

And

The Bidder must have experience of executing similar works in at least 2 (two) no. for railway siding in last five years.

And

The Bidder must have executed single contract of similar work of value of around Indian Rupees 60 Crores (Rupees Sixty Crore only) including cost of materials or Indian Rupees 15 Crores (Rupees Fifteen Crore only) excluding cost of materials in last five years.

Or

The Bidder must have executed two contracts of similar work with value of each contract around Indian Rupees 30 Crores (Rupees Thirty Crores only) including cost of materials or Indian Rupees 7.5 Crores (Rupees Seven Crores and Fifty Lacs only) excluding cost of materials in last five years.

Or

The Bidder must have executed three contracts of similar work with value of each contract around Indian Rupees 20 Crores (Rupees Twenty Crores only) including cost of materials or Indian Rupees 5 Crores (Rupees Five Crores only) excluding cost of materials in last five years.

- III. Notwithstanding anything stated above, DBPL reserves the right to assess the Bidder's capability to perform the work, should the circumstances warrant such assessment in the overall interest of the Owner.
- 7.0 DBPL reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids (IFB) without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
- 8.0 A complete set of bidding documents may be purchased by any interested Bidder on submission of written application and payment (non-refundable) of the cost of the bid documents as mentioned at Clause 4.2 above in the form of a crossed account payee Demand Draft / Pay Order in favor of **DB Power Limited** payable at Mumbai. Issuance of bidding documents to any bidder shall not construe that such Bidder is considered to be qualified. Bids shall be submitted and opened at the address given in Clause 4.1 above in the presence of Bidders' representatives, who choose to attend.
